CIRCULAR

Subject: Implementation of MECL Medclaim Scheme for retired employees & their spouses

We are pleased to inform all concerned that the MECL Medclaim policy for Retired Employees of MECL & their spouses has been implemented w.e.f. 01.05.2018 to 30.04.2019 i.e. for a period 01 (One) year on pan – India basis. Accordingly, Work Order has been placed with M/s. United India Insurance Company Limited, Nagpur, after completion of due tendering process, who have engaged M/s. MDIndia Health Insurance TPA Pvt. Ltd., as Third Party Administrator (TPA) to administer the policy.

For informing all concerned of the above, a press dated has been released in leading national dailies on 01.05.2018. Consequently, the same has been also uploaded on the MECL website along with step by step guidelines for availing cashless hospitalization facility, non cashless/ reimbursement hospitalization facility and OPD facility as will be administered by the Third Party Administrator (TPA) M/s. MDIndia Health Insurance TPA Pvt. Ltd., of M/s. United India Insurance Company Limited. It must also be intimated that press notes on stages of implementation of the scheme had also been given in national dailies on 06.12.2017 and 30.01.2018 for informing the concerned.

Further, the concerned may please take note of the following:

- 1) The cashless hospitalisation facilities as well as post treatment reimbursement under the scheme to the retired employees shall be available in all parts of India
- 2) United India Insurance Company will provide the necessary claim services through Third Party Administrator (TPA) as already referred above
- 3) The TPA will issue Health Card to each enrolled member along with a brochure on comprehensive Claim Procedure and list of Network Hospitals pan India from where treatment can be availed.
- 4) The said Health Card and brochure will be sent to each enrolled members by post within short period to their latest recorded residential address directly by Third Party Administrator (TPA).

In view of above, all Zonal Managers and Project Managers may give wide publicity in and around their local areas to the information provided in this Circular for the benefit of all concerned.
